SAFETYWALLET CONTRACTOR AND SUPPLIER DIRECTORY

Contractor management can be laborious at the best of times, and SafetyWallet offers incentives based on the number of contractors and suppliers, as well as the degree of compliance for each contractor and supplier that is included in the overall compliance portfolio.

SafetyWallet compensates subscribers with additional rewards discounts according to a tiered basis for the number of contractors and suppliers who have been referred to, and subscribed to SafetyWallet:

- 5 Contractors/Suppliers - 2.5%
- 10 Contractors/Suppliers - 5%
- 15 Contractors/Suppliers - 7.5%
- 20 Contractors/Suppliers - 10%
- 25 Contractors/Suppliers - 12.5%

HOW DOES THE SAFETYWALLET DIRECTORY ASSIST WITH GENERATING A RETURN ON INVESTMENT

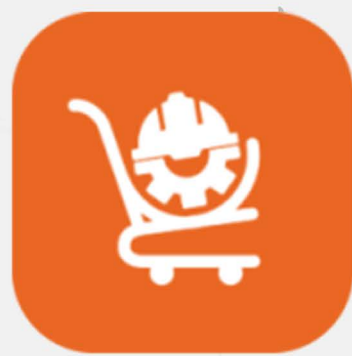

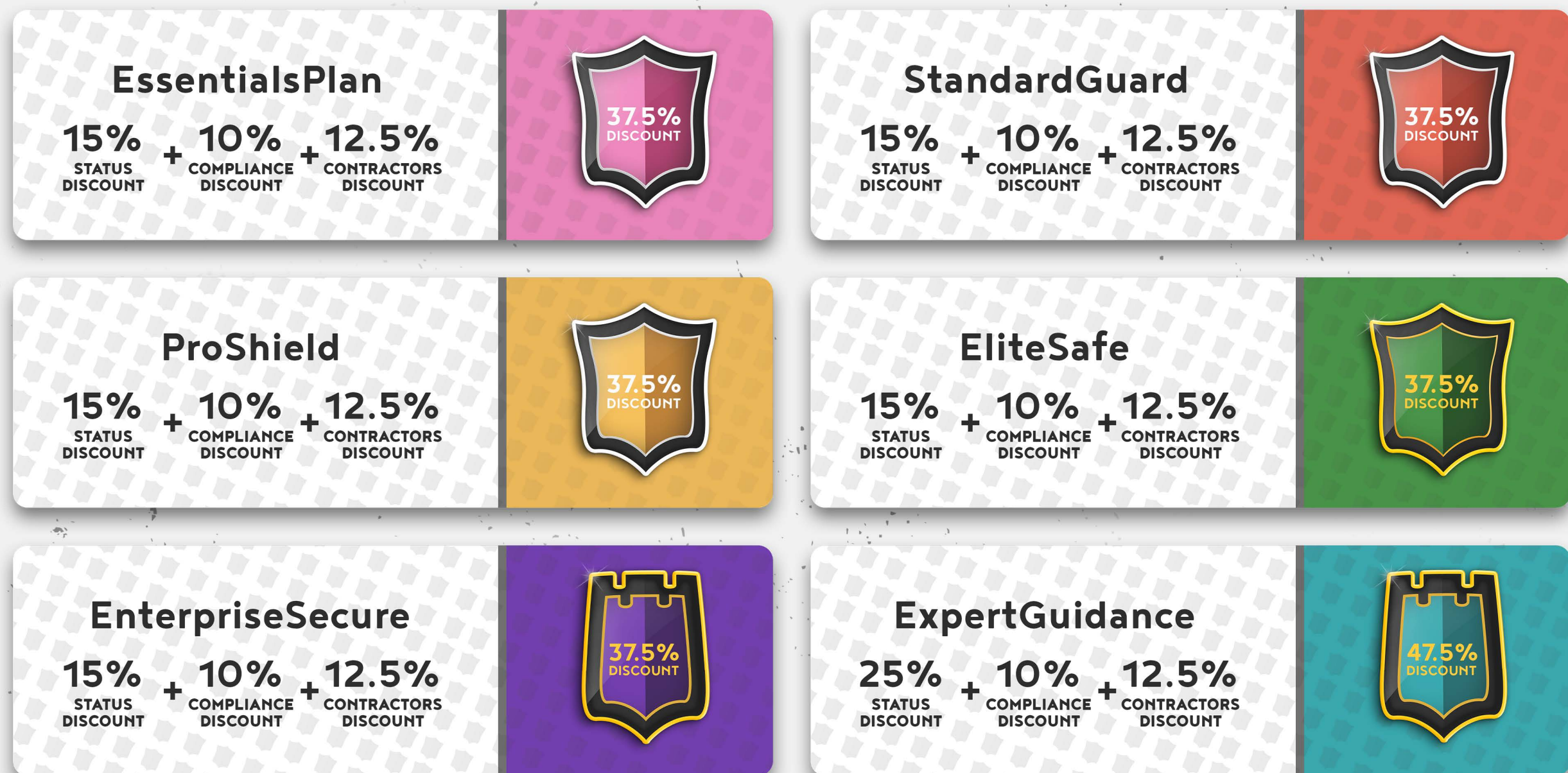
